Role of NAPRA vs PRAs

- **NAPRA:** Facilitates **collaboration** and **national approaches** amongst its Members, the pharmacy regulatory authorities (PRAs).
- **NAPRA Members:** 13 provincial/territorial PRAs + Canadian Forces Health Services.
- NAPRA is **not a regulatory authority** itself and does **not** have any authority over the PRAs, pharmacies, or pharmacy professionals.
- **PRAs:** Regulate pharmacy practice in their respective jurisdictions in the public interest.
- **NAPRA helps the PRAs collaborate** to develop similar approaches to common problems – including by developing programs, documents, and tools for the PRAs to use as they wish.

IMPORTANT

NAPRA work is a model for the PRAs to use. The PRAs will implement differently to meet their needs. So, it is the PRAs that are responsible for enforcement, not NAPRA.

NDS is implemented and enforced by the provinces/territories.






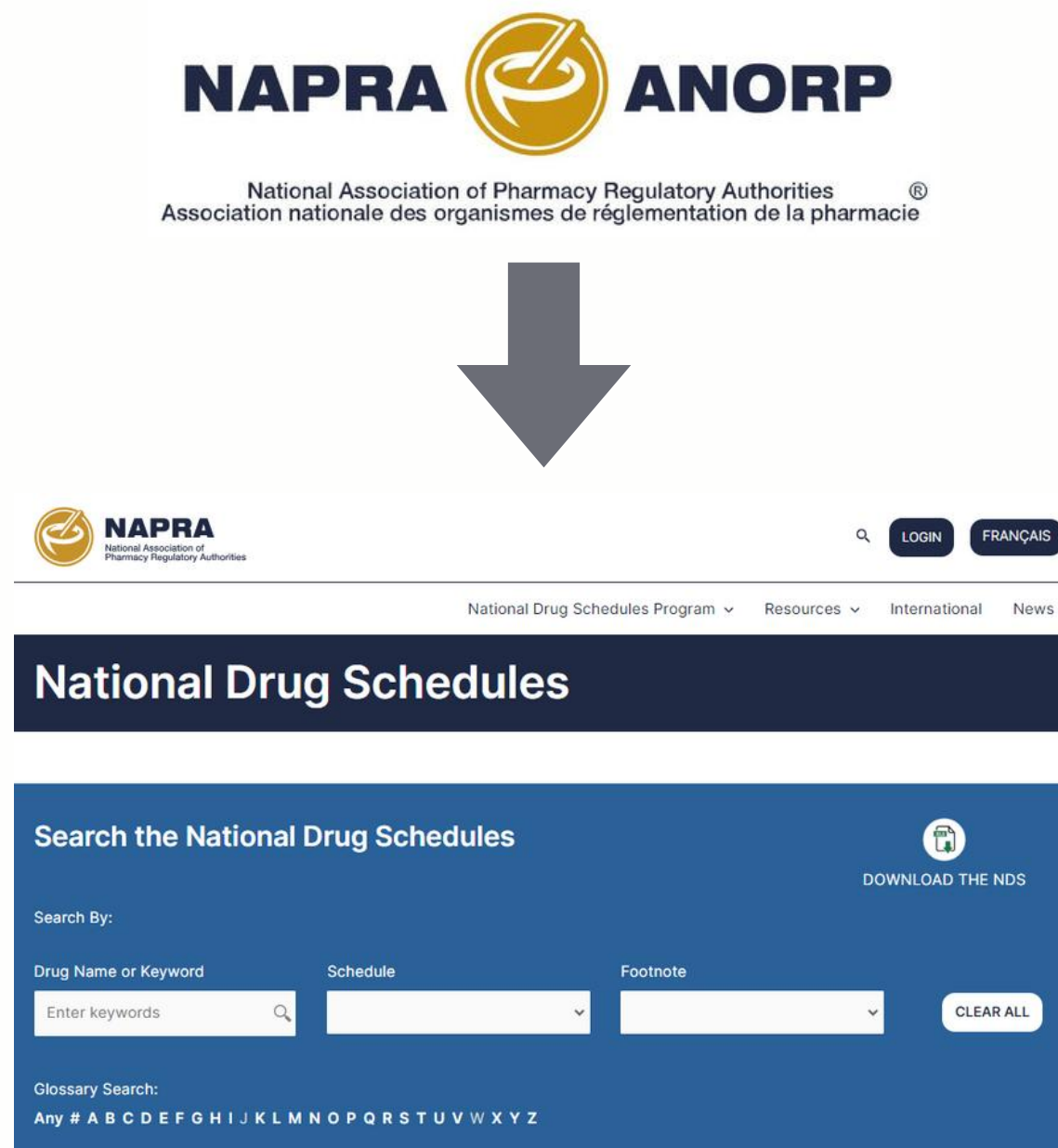

- **Health Canada authorizes drugs** for sale in Canada **and** determines **whether a drug requires a prescription.**
- **Health Canada** lists **prescription drugs** in the Prescription Drug List (**PDL**) or under the *Controlled Drugs and Substances Act* (**CDSA**) – these drugs require a prescription across Canada.
- **NAPRA's National Drugs Schedules** determine the **conditions of sale** for drugs that Health Canada classified as **non-prescription.**

NAPRA's Role in Drug Scheduling

- NAPRA's NDS helps to harmonize conditions of sale for **non-prescription drugs** across jurisdictions.
- The NDS program is **implemented** through **provincial/territorial laws and regulations**.
- There can be **slight differences** in how it is implemented from one province or territory to another – including **possible exceptions**.
- Because it is implemented by the laws and regulations of the province or territory, it is the **province or territory that is responsible for enforcement**.

Prescription required.



SCHEDULE II DRUGS

Pharmacist intervention (consultation) required.



SCHEDULE III DRUGS

Self-selection / pharmacy only
(Consultation must be available but is not required.)



UNSCHEDULED

Can be sold from any retail outlet.




National Drug Scheduling Process

- A specific process is followed for each drug scheduling review – outlined in NAPRA [Bylaw No. 2](#) & [Rules of Procedure](#).
- **National Drug Scheduling Advisory Committee (NDSAC)**
 - 4 meetings pre-scheduled throughout the year; only occur if submission received.
 - Specific pre- and post-meeting procedures must be followed.
 - NDSAC makes a determination on the application of the [scheduling factors](#).
 - NDSAC makes interim scheduling recommendations.
 - 30-day consultation period.
 - Board makes final scheduling recommendations.
 - National Drug Schedules are amended – implementation by the provinces/territories.
